Rebuilding & Restoring South Carolina



A few short days in the aftermath of Hurricane Helene, Chippewa Valley Electric Cooperative (CVEC), and 14 other Wisconsin electric cooperatives responded to a ROPE (restoration of power in an emergency) call to help repair the widespread damage caused by the high winds and rain that came with this catastrophic storm.

Despite the uncertainty of the climate and work conditions they would face, CVEC had linemen willing to accept the call for help. Ultimately, it was determined that two linemen would represent CVEC and make the journey to Aiken Electric Cooperative, Inc. in South Carolina.

To support their efforts, the CVEC crew drove to South Carolina in an aerial lift (aka bucket) truck. The aerial lift truck, vital for repairing overhead power lines, allowed safe access without the need to climb poles.

Given the extensive miles of line that required repair and the rough terrain, this truck was invaluable.

Despite the hurricane's extensive damage, a "tent city" was quickly set up. Linemen were provided basic but functional living arrangements where they slept on cots, used porta-potties, and had access to hot showers, meals, and laundry services. These accommodations allowed crews to

rest and recharge after a long day's work.

Wisconsin crews worked together in the hot, humid weather for long 16- hour days to repair/rebuild three-phase and singlephase lines, set poles, and untangle wires. Even spending one day partnering with local law enforcement to run lines across a normally busy interstate.

The Wisconsin crews met each morning at a local ranch. The rancher donated the space as a meeting point and drop off point for much needed equipment and supplies.

The widespread damage left behind from Hurricane Helene was catastrophic. We are proud to be part of a caring

This is a reminder that the 2024 Winter Preparedness Test for Interruptible Heat (Dual Fuel) Accounts is on Wednesday, November 20. If you are a part of CVEC's Dual Fuel program, your system will be tested on that day. This test makes sure your backup heating works and keeps your home comfortable during load control periods this winter. It also checks that the control equipment is working properly.
