ELIGIBILITY CRITERIA

- ❖ New appliance must be purchased in 2018 and must be installed on cooperative's lines.
- ❖ Recycled appliance must be recycled in 2018 and removed from service on cooperative's lines.
- ❖ New or recycled appliance must be electric.
- ❖ Incentives are in place through December 31, 2018. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Incentive not to exceed 20% of the cost of appliance. Appliance recycling qualifies for the entire incentive, regardless of the recycling cost.
- ❖ Additional eligibility criteria may apply. Contact cooperative for details.
- ❖ Please allow up to 2 months for rebate to be credited to your bill.
- ❖ **All documentation listed below must be submitted no later than 3 months after purchase or recycle date. Rebates submitted after 1/1/19 will not qualify if rebate is not offered in 2019. Rebates submitted after 1/1/19 will qualify for 2019 rebate amount.**
 - ✓ This Incentive Form
 - ✓ A copy of your receipt or invoice for each item purchased
 - ✓ ENERGY STAR label for each new item purchased
 - ✓ For recycled appliances, include documentation showing appliance is in working order
