**ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM** *(Please read)*

- ❖ Rebate for parts is limited to a maximum of 2 elements and 2 thermostats per year, not to exceed \$150 per controlled water heater per year. Rebate amount for replacement parts will not exceed actual cost of parts. Shipping or delivery costs cannot be included.
- ❖ Rebate for service call is limited to \$75 per service call, not to exceed \$150 per controlled water heater per year. Rebate amount will not exceed service call charge. Service call must be performed by professional plumber or electrician to qualify for rebate.
- ❖ Equipment must be a new purchase and installed in 2018. Service call must be in 2018.
- ❖ Installed equipment must be on cooperative's lines and member must be part of CVEC Water Heater Program.
- ❖ Rebates are in place through December 31, 2018, or until funds are depleted. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Please allow up to 2 months for rebate to be credited to your bill. Rebate program subject to change without notice.
- ❖ **Submit the documentation listed below no later than 3 months after install date or service call. Rebates submitted after 1/1/19 will not qualify if rebate is not offered in 2019. Rebates submitted after 1/1/19 will qualify for 2019 amount.**
