EV CHARGERS

2022 Energy Efficiency Incentive Form

ELIGIBILITY CRITERIA

- ❖ New EV charger must be installed on cooperative's lines.
- ❖ EV Chargers will be controlled (not available) between the hours of 2PM – 9PM weekdays.
- ❖ Incentive not to exceed the EV charger cost. Limit one EV Charger rebate per account.
- ❖ Incentives are in place through December 31, 2022. Funds are limited -- please submit required documentation as soon as possible.
- ❖ Required documentation must be submitted within 3 months of EV charger install date.
- ❖ Option 1 - Rebate:
 - \$400 rebate or a free Level 2 EV Charger
 - EV charger must be hard-wired. (receptacle for charger is not allowed)
 - EV charger must be on Dual Fuel (DF) Rate (Rate H), requiring a DF Meter
 - EV Charger must be under CVEC Load Control
 - EV charger must have low voltage control circuit, with max rating of 5A @ 120V
- ❖ Option 2 – Reduced Purchase Price (rebate form not required for this option):
 - EV charger must be ZEF Energy Smart Electric Vehicle Charging Station purchased through CVEC.
 - Reduced purchase price of ZEF Energy Smart Electric Vehicle Charging Station.
 - Please contact CVEC for additional details and current pricing.
 - 7kw ZEF Energy Smart Electric Vehicle Charging Station for \$200 (equivalent to \$800 rebate)
 - 9.6kw ZEF Energy Smart Electric Vehicle Charging Station for \$300 (equivalent to \$800 rebate)
 - 11kw ZEF Energy Smart Electric Vehicle Charging Station for \$450 (equivalent to \$800 rebate)
 - 15kw ZEF Energy Smart Electric Vehicle Charging Station for \$550 (equivalent to \$800 rebate)
 - DF Meter is optional with this option
- ❖ Additional eligibility criteria may apply. Program is subject to change or cancellation without notice. Contact cooperative for details.
- ❖ Please allow up to 2 months for rebate to be credited to your bill.
- ❖ Required documentation listed below must be submitted no later than 3 months after EV charger install date.
 - ✓ This incentive form
 - ✓ A copy of your receipt or invoice for each item with purchase price(s) circled
 - ✓ Include documentation showing the EV charging station has been installed
