ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ Incentive for parts not to exceed \$150 per controlled water heater per year. Incentive amount for replacement parts will not exceed actual cost of parts. Shipping or delivery costs cannot be included.
- ❖ Incentive for service call is not to exceed \$150 per controlled water heater per year. Incentive amount will not exceed service call charge. Service call must be performed by professional plumber or electrician to qualify for incentive.
- ❖ Equipment must be a new purchase and installed in 2025. Service call must be in 2025.
- ❖ Installed equipment must be on cooperative's lines and member must be part of CVEC Water Heater Program.
- ❖ Incentives are in place through December 31, 2025, or until funds are depleted. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Please allow up to 2 months for incentive to be credited to your bill. Incentive program subject to change without notice.
