# WINTER STORM PREPARATION

Extreme winter weather can immobilize an entire region—even for us Wisconsinites. Winter storms can result in difficult road conditions, power outages, and flooding. Take action now to ensure the safety and comfort of your family in the event of extreme winter weather.

#### **Before a Storm**

- Have snow removal equipment on hand or a snow removal service arranged.
- Locate your main water supply and valves; make sure you know how to shut them off in case a pipe bursts.
- Repair roof leaks and keep gutters clear. Trim any tree branches that could fall during a storm. If you have tree branches near CVEC's electrical lines, please contact us. One of our crew members will safely cut the branch or tree for you. We do require members to clean up the cut branch or tree afterwards.
- Winterize your home by caulking and weatherstripping doors and windows, sealing the attic area, and installing storm windows. This will help to keep your family safe and comfortable during a storm and help with the cost of your electric bill throughout the winter.

#### **During a Storm**

- Listen to your radio or television for weather reports and emergency information.
- To conserve fuel, keep your home cooler than normal. Consider temporarily closing off heat to some rooms.
- Stay dry. Change wet clothing frequently to prevent the loss of body heat.
- Watch for signs of frostbite; these include loss of feeling and white or pale appearance in extremities such as fingers and toes. If symptoms are detected, get medical help immediately.
- Drive only when necessary. If you must drive, travel on main roads during daylight hours. Keep others informed of your whereabouts.

#### After a Storm

- Avoid overexertion when shoveling snow. Overexertion can bring on a heart attack, a major cause of death in the winter.
- If you are able, help out neighbors who may require assistance, including the elderly, people with disabilities, and people with infants or small children.
- Follow forecasts and be prepared when needing to travel outside. Major winter storms are often followed by extremely cold conditions.

#### A little forethought and attention to detail will help to ensure that you and your family will stay warm and safe this winter, no matter what the weather is outside.


The following board members are currently serving and have the option to campaign again for these positions:

#### District 7 – John Petska 3-Year Term

Townships of Eagle Point and Anson, and the portion of the Township of Goetz located west of State Highway 27, Chippewa County; and those members of Chippewa Valley Electric Cooperative whose service extensions lie within said townships or portions of townships.

## **RATE ADJUSTMENT PLANNED FOR JANUARY 1**

hippewa Valley Electric Cooperative (CVEC) is committed to providing dependable and reliable electric power to its members while at the same time using members' resources as wisely as possible. The continued goal of your cooperative's board of directors and management team is to keep rates low.

The last few years have been anything but easy as inflation continues to impact every sector, and the energy industry is no exception. A slight increase in rates is needed in 2025 to help our not-for-profit cooperative maintain a strong financial position and continue to provide the reliable service our members have come to expect.

As members of a small, rural cooperative, you should remember that fixed costs and time-sensitive costs in the wholesale rate affect CVEC differently than they do large electric companies. The infrastructure that delivers power to our homes and businesses demands constant maintenance and occasional upgrades to meet evolving technology and safety standards. It's crucial to recognize the pivotal role facility upgrades and maintenance play in sustaining low outage times for our members and safe work environments for our crews. Investing in improvements and maintenance of our electrical system ensures our community receives consistent, high-quality electrical services.

The 4% increase is a measured response to counteract inflating costs. Moreover, the rate adjustment aligns with the cooperative principles of democratic member control and financial responsibility. As a member-owned entity, the cooperative always operates with the best interests of its members in mind. Members will see the change on their February billing statement for January 1–31 usage.

## SCHOLARSHIPS AVAILABLE FOR HIGH SCHOOL SENIORS

This spring, Chippewa Valley Electric Cooperative (CVEC) will be awarding several scholarships to graduating high school seniors of member families through our Federated Youth Foundation Scholarship Program. The scholarship program is funded entirely from unclaimed patronage capital issued by the cooperative and from members who wish to donate their capital credits' earnings to the scholarship program. Please contact CVEC if you wish to do so.

CVEC's scholarship program began in 1998, and since its inception has provided more than \$203,000 in scholarships to area students. An independent scholarship committee composed of retired educators scores the applications based upon merit.

The completed scholarship application must be returned to the cooperative office by April 1. Scholarships will be awarded to the students at an honors ceremony or at graduation.
