BILLING DEMAND

The <u>Coincident (Summer) Demand Charge</u> for the year shall be the average of the customer's peak demand contributions to the peak periods as signaled by the Cooperative during June, July, and August which are used by Dairyland Power Cooperative to establish the Cooperative's wholesale Annual Demand Charge.

The customer's coincident summer billing demand will be charged on the October bill of each year.

The <u>Coincident (Winter) Demand Charge</u> for the year shall be the average of the customer's peak demand contributions to the peak periods as signaled by the Cooperative during December, January and February which are used by Dairyland Power Cooperative to establish the Cooperative's wholesale Annual Demand Charge.

The customer's coincident winter billing demand will be charged on the May bill of each year.

The customer will be alerted to potential peak periods one-half hour in advance of the potential peak period.

The <u>Maximum (Monthly) Demand Charge</u> shall be the maximum kilowatt demand established by the Consumer in any fifteen minute period during the month for which the bill is rendered.

COINCIDENT DEMAND ADJUSTMENT

The coincident demand, (summer and winter) shall be adjusted by a factor of 1.09 times any increase or decrease in the wholesale causation demand from the following base rate:

Summer Peak (Causation) Component \$61.87 Winter Peak (Causation) Component \$28.13

POWER COST ADJUSTMENT

The above rate shall be increased per kilowatt hour by any Power Cost Adjustment or Rate Surcharge on the current month Cooperative wholesale power bill multiplied by a factor of 1.06 to adjust for line losses.

TERMS OF PAYMENT

- All billing charges are due upon receipt.
- Payment is considered made when payment is received in Cooperative office.
- Final date for payment is not later than 20 days after the date of issuance of the bill or as printed on the billing statement.
- Any unpaid balance as of 4:00 pm on the final date of payment will be subject to a penalty of \$.30 or 1-1/2 percent, whichever is greater.
